Financial Report:

Report prepared by bookkeeper Cori Szepkouski for Fiscal Year September 2019 – August 2020.

Report was read by Committee Member Dan Rose. Questions were taken from Property Owners in

attendance with detailed explanations/answers given. Note: A copy of this Fiscal Year's Financial Report

was included in the Annual Mailing to Property Owners - See Report.

Summary:

Total Income: \$114,900 Legal Fees: \$11,000

Expenses:

- Paving & Maintenance: \$83,500

- Gate Remodel and Repair:\$14,581.81 (Attendees applauded the investment in the gate)

- Insurance: \$7,000 liability

- Power and Phone for gate: \$1,400

- Accounting: \$500/month Attendees applauded and thanked Bookeeper C. Szepkouski for

all she does in helping manage our Community)

Accounts Receivable - \$31,000 (Unpaid Assessments)

Emergency Account Balance: \$23,000

Emergency Reserve Account: Targeted at \$30,000 on ongoing basis. This is intended to be used for true road safety emergencies such as the loss of a road in a storm. Account was reduced below this level at this time due to paving and construction expense but will be restored with the upcoming collection of assessments.

Road Report: by Property-Owner James Szepkouski

Provided hand-out to attendees of color-coded map of entire road system with explanation as follows:

Map broken into strategic categories

- Road sections in good condition
- Road sections needing AC patching and seal-coating
- Road sections needing AC overlay only
- Road sections needing removal and replacement
- Existing unpaved roads
- Existing unpaved roads needing grading
- Pot holes needing patching
- New curbs needed to control water flow line
- -Flow line work needed / add rip-rap
- -Arizona crossing additional concrete work was done this year on the down flow side.

Additional Notes:

Goal is to have reflectors on all sections of roads as new asphalt overlay is installed.

Piggy-backing is the term used for unauthorized traffic following you through the community gate. The request for all residents is to pause and let the gate close behind you to prevent unauthorized entrants into our Community.

Property-owners are reminded that keeping brush cleared from the roadway is the responsibility of the

each property-owner.

Brush should be kept to a minimum of 4' from the edge of the asphalt to keeping our roadsides clear and

passable.

Legal Report: by Committee Member Jan Geller

Small Claims Cases / Accounts Receivable

A detailed breakdown was provided by Jan who has been volunteering to represent Rancho Heights in

Small Claims Court relative to the collection of delinquent assessments. As of the date of this meeting,

only 6 property owners were delinquent in their assessments. These 6 owners will be processed through

Small Claims Court in the next few months due to COVID 19. Superior Court: We have one case in

which the Court has ruled in favor of Rancho Heights with collections pending.

Sherry Simmons: Mountain Lions: Please report sightings so they can be reported to State and

Mountain Lion Foundation. If you see a mountain lion: "de-escalate," let them know you are a predator

and bigger than them. Never run, make eye contact, make yourself big with arms above your head.

Make noise Use a Thunder Whistle or YELL at the lion. It is possible to co-exist safely.

you can have your cell number or land line be as your contact number from the gate dialer.
